A Plan Commission meeting of the Town of New Haven was called to order by Ken Seguine at the New Haven Town Hall on Wednesday, October 19, 2022 at 7:30 pm.

ROLL CALL

Andrew French, Amber Carlsrud, Jeff Carlsrud, Ken Seguine, Doug Sander were present. Also present was Dale Wiehoff, Bill, Jayme Beyrer.

APPROVAL OF AGENDA

Motion by Seguine, approved by Amber Carlsrud, seconded by Sander to approve the meeting agenda of October 19, 2022, as distributed. Motion carried unanimously.

BUSINESS

Amber talked about her revisions to the Mission & Vision Statement. She noted that she will share to the group in Google Docs. She asked if members could look it over and respond with feedback.

Ken talked about the Assignment of Tasks to complete the Land Plan.

Jayme will look for deed to Theorin Park. She noted that Theorin French was the owner of the land, no relation to Andrew French.

Ken noted that someone should scan the gazette, plat maps, and Bolen map at the Dunn County Courthouse.

Ken said he will finalize an outline for the Plan, especially the history of the area. He noted that we do have an expanded Indigenous & Local history, from Andy Gaertner at the Land School. Ken passed out copies to all members.

Andrew will create a map to identify water features.

Dale mentioned that we should also incorporate Jayme's history of the business of Connorsville, along with Gaertners piece.

Jayme mentioned adding Splinterville to the brief history in the Land Plan.

Ken talked to Susan Badke at Western Wisconsin Regional Planning and the 2020 census is not released yet. Ken noted that Dale suggested tackling transportation.

Jeff showed a map of the roads of the township. Amber noted that we should get the plan of Hwy 64 from Dunn County. Jeff noted that it might be a state or federal plan.
